


# USAMMA'S MEDICAL MAINTENANCE MANAGEMENT DIRECTORATE

## MAINTENANCE OPERATIONS DIVISION

- Operate the AMEDD's three ISO9001 registered, depot-level medical maintenance facilities
- Manage and run the AMEDD Maintenance Sustainment Program
- Provide sustainment and depot-level support for standard and select nonstandard medical equipment
- Support the Army [Active, Reserve, & National Guard], authorized DoD activities, and other Federal agencies
- Calibrate Special Purpose Test, Measurement, & Diagnostic Equipment [TMDE]
- X-Ray Tube Rebuild Program

## NATIONAL MAINTENANCE PROGRAM

- AMEDD lead agent for the Overall AMEDD National Maintenance Program
- Ensures integration of maintenance policies and other related functions between Commands
- Provides maintenance policy, initiatives, procedural guidance, and assistance in the development, acquisition and sustainment of medical equipment
- Ensure maintenance program is incorporated into Doctrine, Strategic Direction and Policy statements
- Lead agent for ARFORGEN Medical Maintenance related policy issues
- Serves as resource for information to assist Integrated Logistics Support [ILS] process within the Program Management Office [PMO]



## FORWARD REPAIR ACTIVITY—MEDICAL [FRA-M]

- Supports Medical Treatment Facilities in Iraq and Afghanistan
- Mentors in Theater medical equipment repairers [MOS 68A]
- Augments the USAMMA Medical Logistics Support Team for Army Prepositioned Stocks [APS]
- Assists with Theater Relief in Place/Transfer of Authority to ensure mission capable systems

## REMOTE DIAGNOSTIC ACCESS [RDA]

- Real-Time System Maintenance Management
- Remotely Diagnose System Problems
- Reach Back Medical Maintenance Support to Subject Matter Expert [SME]
- Improves Mission Readiness
- Optimize Time to Repair
